STEWARDS SUMMARY OF JUDICIAL OUTCOMES, Update 2: issued Sunday 18 July 2021 at 1715hrs.

Matters from Race 2:

Race Director Incident Determinations

There were no penalties imposed.

Stewards' Decisions - Penalties imposed

Having received a report from the DSA and after reviewing Television footage the Stewards determined Car 61 – Nash Morris breached Schedule B2 Article 2.1.1 Careless Driving for making contact with Car 38 at Turn 10 on Lap 7 causing Car 38 spin and drop positions. The Steward imposed a Post-Race Time Penalty of 15 seconds.

Following a report from the DRD that Car 61, Reef McCarthy entered the Pit Lane after receiving the Chequered Flag was displayed in breach of Rule D11.5.10.3. The Stewards imposed a Fine of \$500.

Following a report from the DRD that Car 35, Jason Gomersall entered the Pit Lane after receiving the Chequered Flag was displayed in breach of Rule D11.5.10.3. The Stewards imposed a Fine of \$500.

Matters from Qualifying Race 2:

Race Director Incident Determinations

Following a request for an investigation from Matt Stone Racing Pty Ltd that Car 30 was impeded by Car 88 at the entry to turn 7 on its fastest lap. Following a review of all available broadcast footage, including the in-car judicial camera from Cars 30, the DRD in consultation with the DSA determined no breach of the rules by Car 88 and did not warrant being referred to the Stewards

<u>Stewards' Decisions – Penalties imposed</u>

There were no penalties imposed.

Matters from Race 1:

Race Director Incident Determinations

The DRD and DSA conducted an investigation into an incident between Cars 78 and 27 resulting in contact between numerous cars. Following a review of all available broadcast footage, including the in-car judicial camera from Cars 54 & 27, the DRD in consultation with the DSA determined no one driver was wholly or predominately to blame.

Stewards' Decisions - Penalties imposed

There were no penalties imposed.



Matters from Qualifying:

Race Director Incident Determinations

There were no determinations.

Stewards' Decisions - Penalties imposed

Having received a report from the DSA and reviewing Television footage the Stewards determined Car 38 - Jack Sipp breached Schedule B2 Article 2.1.1 Careless Driving by impeded Car 28 approaching Turn 2. Stewards imposed a 3 Grid Spot penalty Car 38 for Race 1.

Matters from Practice 1:

Race Director Incident Determinations

There were no determinations.

Stewards' Decisions - Penalties imposed

The Stewards imposed the following penalties after the session.

- Car 67, Nash Morris breached Rule D11.4.2 Pit Lane Speed Limit, 46km/h at Pit Entry, Stewards imposed a penalty of \$200.00 Fine.
- Car 77, Blake Fardell left Pit Lane whilst the red light was displayed at Pit Exit in breach of Schedule B2- Rule 6.3, Stewards imposed a 5 Grid Penalty in Race 1.
