**STEWARDS SUMMARY OF JUDICIAL OUTCOMES, Final: issued Sunday 4<sup>th</sup> December 2022 at 1530hrs.**

#### **Matters from Race 2:**

##### Race Director Incident Determinations

There were no determinations.

##### Stewards' Decisions – Penalties imposed

A Five (5) second Time penalty was imposed on Car 18 Matt Chahda – Careless Driving, for contact to the rear of Car 777 at Turn 5 on lap 1, and gained a position as a result

A Fifteen (15) second Time Penalty was imposed on Car 3 Thomas Maxwell, for a Safety Car restart on Lap 12, where Car 3 passed Cars 27 and 10 before the Control Line

#### **Other Matters from Race 1:**

Following a Hearing, the Stewards imposed a Fine of \$500 on Nemo Racing Pty Ltd as the Authorised Team Representative and Driver, had failed to attend the DRD office as requested for an investigation. The Team Representative had failed to check his emails/text messages prior to leaving the circuit.

##### Race Director Incident Determinations

There were no determinations.

##### Stewards' Decisions – Penalties imposed

During the Race, the Stewards imposed a Fifteen (15) second Time Penalty to Car 8 Lachlan Dalton for a driving infringement (Careless Driving), contact to Car 11 Zane Morse at Turn 6.

Following a Post-Race investigation and admission to the Breach of Schedule B2 Rule 2.1.1 – Careless Driving by Ryal Harris Car 58, contact to the rear of Car 38 Cameron Crick on Lap 13 at Turn 6, the Stewards imposed a Twenty-two (22) second Time Penalty (equivalent to a PLP) to Car 58.

Following a Post-Race investigation and admission to the Breach of Schedule B2 Rule 2.1.1 – Careless Driving by Angelo Mouzouris Car 6, contact to the rear of Car 18 Matt Chahda on Lap 13 at Turn 7, the Stewards imposed a Fifteen (15) second Time Penalty to Car 6.

#### **Matters from Practice 2:**

##### Race Director Incident Determinations

There were no determinations.

##### Stewards' Decisions – Penalties imposed

Following an Investigation and admission by Matt Chahda Motorsport to a breach of Rule D21.3.5 - failed to ensure the Judicial Camera in the car was functional whilst on the circuit, and as Car 18 was involved in an on track investigation, the Stewards imposed a Fine of \$2,500

After the Session and following an admission by Matt Chahda Car 18, to a breach of Schedule B2 2.1.1 - Careless Driving, where Car 18 made contact to the rear of Car 2 at Turn 3, the Stewards imposed a Three (3) Grid Placing Penalty on Car 18 for Race 1.

After the Session and following admission by the driver of Car 33 Adam Wallis, to a breach of Schedule B2 2.1.1 - Careless Driving, impeding Car 78 on approach to Turn 14, the Stewards imposed the Penalty of a Reprimand.

Following the Session the DRD received a report from Supercars Technical and an admission to the breach by the following Teams, the Stewards imposed a Fine of \$1,000 for failing to provide Judicial Camera footage when requested in breach of Rule D21.3.5

- Image Racing – Car 999
