#### Matters from Race 2:

#### Race Director Incident Determinations

The RD in consultation with the DSA investigated contact between Car 18 Matt Chahda and Car 99 Jordan Boys at Turn 9. The DSA's view was that Car 18 moved under brakes into Turn 9 and the contact was a consequence and for those reasons the matter was not referred to the Stewards.

# .<u>Stewards' Decisions – Penalties imposed.</u>

The Stewards imposed 5 second Time Penalty on Car 38Cameron Crick for continually exceeding track limits at Turn 2.

#### Matters from Race 1:

#### Race Director Incident Determinations

Image Racing submitted a Request for Review post-race alleging Car 92 Cameron McLeod made contact with the rear of Car 999 Jobe Stewart at Turn 7 loosing numerous positions and sustaining damage. The Race Director in consultation with the DSA reviewed the Broadcast footage and determined that Car 92 did not make contact with the rear of Car 999.

The DRD together with the DSA investigated the following Incidents during the Race and determined each matter did not warrant referral to the Stewards:

- Contact between Cars 25 and 88 at Turn 14
- Contact between Cars 49 and 78 at Turn 9
- Contact Between Cars 27 and 25 at Turn 5
